# RESOLUTION DECLARING RESULTS OF BOARD OF TRUSTEES ELECTION HELD April 4, 2017

WHEREAS, on the 4<sup>th</sup> day of April, 2017, there was held by the BOARD OF TRUSTEES OF COMMUNITY COLLEGE DISTRICT NO. 519, COUNTIES OF STEPHENSON, OGLE, JO DAVIESS, AND CARROLL AND STATE OF ILLINOIS (hereinafter referred to as the "Board") in and for such district, an election for the purpose of electing three Trustees for said Board for the full term of six years; and

<u>Section 1</u>: That the election held on the 4<sup>th</sup> day of April, 2017, was held in all respects as provided by law and that the returns of said election have been duly canvassed by the Stephenson County Clerk and filed with the Secretary of the Board.

<u>Section 2</u>: That the Stephenson County Clerk found from a canvass of the returns of said election that the total votes were cast at said election in favor of the persons stated below.

<u>Section 3</u>: That for the full term of six years, Pennie Groezinger received 9,001 votes, Steven Jennings received 8,097 votes, Douglas Block received 7,912 votes, and Joe M. Kanosky received 7,193 votes,

<u>Section 4</u>: That Pennie Groezinger, Steven Jennings, and Douglas Block, having received the highest number of votes cast for any candidate for the full term of six years, are hereby elected to the office on this Board for full terms of six years each.
