<u>Section 1</u>: That the election held on the 4th day of April, 2023, was held in all respects as provided by law and that the returns of said election have been duly canvassed by the Stephenson County Clerk and filed with the Secretary of the Board.

<u>Section 2</u>: That the Stephenson, Ogle, Jo Daviess, and Carroll County Clerks found from a canvass of the returns of said election that the total votes were cast at said election in favor of the persons stated below.

<u>Section 3</u>: That for the full term of six years, Pennie S. Groezinger received 5,399 votes, Douglas Block received 4,807, and Mary Kaufman received 4,372.

<u>Section 4</u>: That Pennie S. Groezinger, Douglas Block, and Mary Kaufman, having received the highest number of votes cast for any candidate for the full term of six years, are hereby elected to the office on this Board for full terms of six years each.
